ART CLUB ENTRY AND ATTENDANCE POLICY

Introduction

Rachel Grove Art Studio is committed to providing a safe, inclusive, and supportive environment for all children who wish to explore their creativity through art. However, there may be certain situations where the Studio reserves the right to refuse entry or continued attendance to children. This policy outlines the circumstances under which such decisions may be made.

Safety and Well-being

Disruptive Behaviour

If a child consistently displays disruptive behaviour that hinders the learning experience of others, the studio reserves the right to address the issue with the child and their parents or guardians. In cases where the behaviour persists despite interventions, entry or continued attendance may be refused.

Failure to Comply with Policies

Children and their parents or guardians are expected to adhere to all Studio policies, including safety guidelines, code of conduct, and any other rules set forth by Rachel Grove Art Studio. Failure to comply with these policies may result in refusal of entry or continued attendance.

Non-Payment of Fees

Participation in Rachel Grove Art Studio's classes or programs is subject to timely payment of all fees. If a child's fees remain unpaid after a specified grace period, the Studio may refuse entry or continued attendance until the outstanding fees are settled.

Capacity Limitations

Lack of Suitable Accommodation

In such cases, entry or continued attendance may be refused if it poses a risk to the child's well-being or the overall class experience.
